

INSTRUCTIONS FOR USE

Manufacturer: Českomoravská textilní s.r.o., Černovická 619/13, 617 00 Brno, Czech Republic

Product: **Disposable protective clothing ADSAFE against infectious agents, ensuring full body protection – coverall type 6-B (type 6) or partial body protection – gown type PB [6]-B (type PB [6]).**

Clothing versions: **1) Coverall art. DPC Light21 (type 6-B, type 6)
2) Gown art. DPG Light21 (type PB [6]-B, type PB [6])**

Materials used: **PFN SMS BICO 80/20**

Material composition: 80% polypropylene/ 20% polyethylene, grammage: 35 g.m²

The product has been assessed from the point of view of the basic requirements determined by Regulation (EU) No. 2016/425 of the European Parliament and of the Council by the specific requirements of the harmonised standards ČSN EN 14126:2003, ČSN EN 13034:2005+A1:2009 in connection with ČSN EN 14325:2004 and ČSN EN ISO 13688:2014. Assessment of conformity was performed by Notified Body No. 1021 Textile Testing Institute Brno.

This concerns **PPE: Category III**.

The product is subject to regular inspection by the notified body Textile Testing Institute Brno.

FIELD OF USE:

The product is intended for single use in workplaces or operations where full or partial protection against infectious agents is required. It prevents infectious agents from reaching the skin and from spreading among the population. Examples of use in facilities such as: microbiology laboratories and medical facilities.




The product also serves as protection against spraying with small amounts of chemicals in operations where liquid chemicals are used in given concentrations. Examples of activity are: in various spraying operations in the food industry and in agriculture.

This clothing provides the levels/classes of protection listed in the tables below.

This clothing is designed to be worn over outerwear.

MEANING OF MARKINGS:

Is given by the ČSN EN 14126:2004 and ČSN EN 13034+A1:2009 standards in connection with ČSN EN ISO 13688:2013.



DPG Light21 (type PB [6]) does not meet the requirements of the ČSN EN 13034+A1 standard for the whole garment and therefore concerns partial protection of the body.



MAINTENANCE OF THE PRODUCT:

This concerns disposable clothing.

WARNING:

Before using the clothing, visually inspect the clothing to ensure that it is not damaged and that all closure systems are functional (ribbon closures, etc.).

The clothing should be properly fastened before use.

Dispose of the clothing properly after use.

Do not use damaged clothing!

Additional protective equipment must be used to ensure protection of other parts of the body (head, arms and legs) with the same level of protection.

If the product is used, stored or handled in any manner other than that specified, it may be subject to deterioration or change in function.

PACKAGING AND STORAGE

Products must not be stored in dusty or damp environments.

Clothing is packed and shipped in PE bags.

The product must be stored in closed, dark and dry warehouses, protected from radiant heat.


